

Faculty of Manufacturing Technologies of the Technical University in Košice with the seat in Prešov (hereinafter referred to as "FMT TUKE") in the meaning of § 22 (3) of Act No. 131/2002 Coll. on universities and Amendments and Additions to Certain Acts, as amended (hereinafter referred to as the "Law on Universities"), the Statute of the FMT TUKE, Annex No. 1: Method of election of the candidate for Dean and the method of acceptance of the proposal for his/her dismissal and based on Resolution 10/2024 announces **the election of the candidate for the Dean of FMT TUKE for the term of office from 1<sup>st</sup> January 2025 to 31<sup>st</sup> December 2028.**

## II.

The election of a candidate for the Dean of the FMT TUKE will take place at a joint election assembly formed by the Election Commission for the election of the Dean of FMT.

**The deadline for the submission** of candidates for the position of Dean of the Faculty of Manufacturing Technologies of TUKE is from **12<sup>th</sup> August 2024 to 23<sup>rd</sup> September 2024.**

## IV.

Proposals shall be submitted by the Act on Universities, the Statute of the FMT TUKE, and the internal regulations of the FMT TUKE.

A. Data regarding **the proposed candidate** for the Dean:

- a. name, surname, titles of the proposed candidate, scientific rank,
- b. age, address for delivery of documents, email, and telephone number of the proposed candidate,
- c. Certificate of Good Character no older than 3 months,
- d. the place and date of submission of the proposal and the handwritten signature of the proposer.

B. The following hand-signed documents must be submitted as a **mandatory annex** to the proposal:

- a. structured professional curriculum vitae of the proposed candidate,
- b. programme theses with a proposal for the FMT TUKE development strategy,
- c. written declaration of the proposed candidate that they agree with the candidacy,
- d. consent of the proposed candidate to the processing and publication of their data for candidacy for the Dean of FMT TUKE, in particular, the structured curriculum vitae and the programme theses:

*“By my signature, I confirm that I agree with my candidacy for the Dean of the Faculty of Manufacturing Technologies of the Technical University of Košice with the seat in Prešov for the term of office from 1<sup>st</sup> January 2025 to 31<sup>st</sup> December 2028. At the same time, I agree to the publication of my professional curriculum vitae and programme theses.”*

**An incomplete proposal that does not contain all the required annexes as specified in this declaration will not be accepted.**
